
Reeve Glen Dow Called the Meeting to order at 10:20 am.


EMO Kevin Shortt - COVID Update

Kevin Shortt EMO coordinator spoke to council about COVID-19 - 207,855 cases worldwide with 8700 deaths in 160 countries. Currently Saskatchewan has 16 cases. Canada has 635 cases. An estimated 30-70% of Canadians are projected to get COVID-19.
