#### **Lone Rock Hamlet Board**

- 2. False and misleading claims of authority outside the scope of the OHB.
- 3. Issuance of false threats based on misinterpretation of the Municipalities Act.
- 4. Ongoing deceptive practices undermining municipal governance and public trust.

#### Be it resolved that:

- 1. The RM of Wilton No. 472 immediately removes the members of the Lone Rock OHB, consisting of Donna Woods, Lloyd Ludwig, and Tracy Kashuba, and those representing themselves as working on behalf of Lone Rock being Terry Kashuba & Victoria Yakimovich (of Vegreville, AB) to preserve the integrity of municipal governance.
- 2. The RM continue to provide full administrative responsibility for the Hamlet of Lone Rock, ensuring compliance with municipal laws and regulations.
- 3. Restrictions are imposed on further submissions or communications from Donna Woods, Lloyd Ludwig, Terry Kashuba and Tracy Kashuba, Victoria Yakimovich.
- 4. Additional formal actions may be implemented if further violations are identified.
